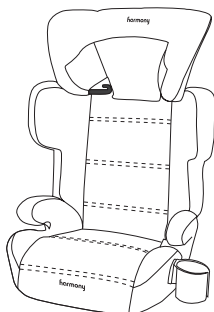

GENERAL WARNINGS



WARNING!

The safety of your child and the effectiveness of this booster seat depend on:

1. **Selecting a suitable location** for the booster seat in your vehicle.
2. **Properly routing the vehicle seat belt.**
3. **Properly securing both your child and the booster seat in the vehicle** using a seat belt designed to restrain both the booster seat and your child. Many seat belts are **NOT** safe to use with this booster seat. Please review the sections "Safe/Unsafe vehicle seat belt systems" carefully. If in doubt about installing this booster seat, consult the vehicle owner's manual or call the Harmony Customer Service Department.

Please check all local laws related to car seats when traveling.



WARNING!

FAILURE TO PROPERLY READ, FOLLOW AND USE THESE INSTRUCTIONS AND THE BOOSTER SEAT LABELS INCREASES THE RISK OF SERIOUS INJURY OR DEATH IN A SHARP TURN, SUDDEN STOP OR CRASH. Your child's safety depends on the proper installation and use of this booster seat. Even if this booster seat seems easy to install and use on your own, it is **VERY IMPORTANT** to read and understand these instructions and the vehicle owner's manual.

Follow all labels on this booster seat and in these written instructions. **DO NOT INSTALL OR USE THIS BOOSTER SEAT UNTIL YOU READ AND UNDERSTAND THE INSTRUCTIONS IN THIS MANUAL AND IN YOUR VEHICLE OWNER'S MANUAL.**

NO BOOSTER SEAT CAN GUARANTEE PROTECTION WHEN THE VEHICLE IS SERIOUSLY IMPACTED. However, when correctly installed, a booster seat will substantially improve the chances for survival and reduce the risk of serious injury in most crashes.

Carefully follow the instructions in this manual and in your vehicle owner's manual. If there is a discrepancy between the two, the vehicle owner's manual must take precedence with regards to seat belts and/or airbags.

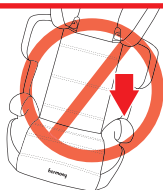
- ! USE THIS BOOSTER SEAT FORWARD-FACING ONLY.**
- ! DO NOT USE THIS BOOSTER SEAT** without properly assembling it.
- ! DO NOT** allow children to play with this booster seat.
- ! NEVER** leave children alone in a vehicle under any circumstance.
- ! It is recommended** that children are not left in their child restraint system unattended.
- ! Set a good example by ALWAYS** wearing your seat belt. Make it a firm rule that the vehicle does not move until everyone is buckled up. **MAKE NO EXCEPTIONS.**

- ! Harmony Juvenile Products advises against loaning or passing along a booster seat. **DO NOT USE A SECOND-HAND BOOSTER SEAT** or a booster seat whose history you do not know.
- ! To prevent injury due to deterioration, hidden damage, etc., discontinue use of this booster seat if it is older than **SIX (6) YEARS**. There is an expiry date for use of this booster seat indicated on the underside of the booster seat base. **STOP USING THE BOOSTER SEAT AND THROW IT AWAY** after the date indicated. Please dispose of the unit in a way others cannot reuse it (e.g. use a dark trash bag, do not sell to a thrift shop or in a garage sale, etc.).
- ! Store the booster seat in a safe place when not in use. **DO NOT** place heavy objects on top of the booster seat while in storage.
- ! **DO NOT** remove any stickers or warnings as they contain important information.

USAGE WARNINGS

WARNING!

- ! **ALWAYS** ASSIST YOUR CHILD WHEN GETTING INTO AND OUT OF THE BOOSTER SEAT.
- ! **NEVER** LET YOUR CHILD LEAN ON THE ARMREST WHEN GETTING INTO OR EXITING THE BOOSTER SEAT TO PREVENT THE SEAT FROM TIPPING.
- ! **ENSURE** THAT THE BOOSTER SEAT IS LEVEL, STABLE AND DOES NOT ROCK SIDE-TO-SIDE. IF THE BOOSTER SEAT IS NOT STABLE, TRY ANOTHER SEATING LOCATION. IN VEHICLES WITH WIDE, FLAT SEATS, A ROLLED TOWEL CAN BE USED ON THE OUTBOARD (DOOR) SIDE TO ADD STABILITY TO THE BOOSTER SEAT.
- ! **DO NOT ADD ANYTHING BEHIND OR UNDER THE BOOSTER SEAT.**



Harmony Juvenile Products recommends keeping your child in a forward-facing car seat with a harness until they reach the top height or weight limit allowed by your car seat's manufacturer. Once your child outgrows the forward-facing car seat with a harness, it's time to travel in a booster seat, but still in the back seat.

The *National Highway Traffic Safety Administration* (NHTSA), the *U.S. Department of Transportation* and Transport Canada recommend that children under the age of 13 years be placed in the back seat of the vehicle and away from active front airbags.

According to accident statistics, **CHILDREN ARE SAFER WHEN PROPERLY RESTRAINED IN THE REAR SEATING POSITIONS THAN IN THE FRONT SEATING POSITION. THE SAFEST POSITION BEING THE CENTER IN THE EVENT OF A POSSIBLE SIDE IMPACT COLLISION.**

Please study the section "Vehicle seating positions".

Many local police and fire departments frequently hold safety inspection events to ensure that booster seats are properly installed. Please contact your local emergency services department to see if and when they offer this service.

! DO NOT use any load bearing contact points other than those described in the instructions and marked in the child restraint.

! DO NOT allow others to install or use this booster seat unless they read and understand all the instructions and labels.

! DO NOT GIVE THIS BOOSTER SEAT to someone else without also giving them this instruction manual. Additional instruction manuals can be downloaded directly from www.harmonyjuvenile.com.

! To ensure proper booster seat use, keep and store this instruction manual and refer to it when necessary.

! DO NOT LEAVE A BOOSTER SEAT UNSECURED IN YOUR VEHICLE. In a collision, sharp turn or sudden stop, an unsecured booster seat can injure other occupants. Remove it or make sure that it is securely attached to the vehicle using LATCH (if available) or the vehicle's 3-point lap-and-shoulder belt, even when not in use.

INJURY WARNINGS

- ! **INJURIES MAY OCCUR EVEN IF YOU ARE NOT IN A CRASH** if the booster seat is not properly installed or if your child is not properly secured in the booster seat.
- ! The rigid items and plastic parts of a child restraint shall be so located and installed that they are not liable, during everyday use of the vehicle, to become trapped by a movable seat or in a door of the vehicle.
- ! **DO NOT** leave folding vehicle seats unlatched. In the event of a sharp turn, sudden stop or crash, a loose seat back could prevent the booster seat from protecting the child as well as it should.
- ! The vehicle front seat headrest that the child faces while in the booster seat should be in its lowest position. **ENSURE** that the back of the vehicle seat facing the child is completely padded with no hard or potentially harmful objects.
- ! It is recommended that any luggage or other loose objects liable to cause injuries in the event of a collision shall be properly secured. In the event of a sharp turn, sudden stop or crash, loose objects will keep moving, potentially causing serious injuries.
- ! The child restraint shall not be used without the cover. It **MUST** always be used with the fabric cover provided by the manufacturer.
- ! The seat cover should not be replaced with any other than the one recommended by the manufacturer.
- ! **PARTS OF THE BOOSTER SEAT COULD BECOME HOT ENOUGH TO BURN THE CHILD IF LEFT IN THE SUN.** Contact with these parts can injure your child. **ALWAYS** touch the surface of any metal or plastic parts before putting your child in the booster seat. Cover the booster seat with a towel or blanket when the vehicle is parked in direct sunlight. **KEEP AWAY FROM SUNLIGHT, OTHERWISE IT MAY BE TOO HOT FOR THE CHILD'S SKIN.**

VEHICLE WARNINGS

- ! Use **ONLY** the vehicle's 3-point lap-and-shoulder belt system when restraining a child in this booster seat. **DO NOT** use this booster seat with 2-point vehicle belts (lap-belt only or shoulder-belt only). Your child would be seriously injured in the event of a crash.
- ! **DO NOT** use this booster seat with unsafe vehicle seat belts listed in section "Unsafe vehicle seat belt systems" of this manual.
- ! **DO NOT** use this booster seat if it can't be properly installed. It is possible that your vehicle has no suitable seating position for this booster seat due to seat belt type, airbag system and/or lack of location of a tether strap anchor. Read and follow these instructions, and your vehicle owner's manual carefully.

CERTIFICATIONS - NORTH AMERICA

This booster seat conforms to the *Federal Motor Vehicle Safety Standards (FMVSS) section 213, 213b, the Canadian Motor Vehicle Safety Standards (CMVSS) 213.2*, and **IS CERTIFIED** for use in the following classes of vehicles **ONLY**: multi-purpose passenger vehicles, passenger cars, and trucks. Harmony Juvenile Products has also validated compliance through independent laboratory testing.

This restraint is **NOT CERTIFIED** for aircraft use. Aircraft seats are not equipped with 3-point lap-and-shoulder belts which are required for use with this booster seat.

- ! Only suitable for use in the listed vehicles fitted with 3-point with retractor safety-belts.

This booster seat must **NOT** be used in homes, boats, buses, motorcycles, motor homes, or any other vehicles that have non-forward-facing seats, missing seat belts, or whose seat belts do not meet the requirements of this booster seat.

This booster seat is compatible with vehicle child restraint Lower **A**nchors and **T**ethers for **C**hildren (LATCH).

CERTIFICATIONS - EUROPE

This is a “Universal” child restraint. It is approved to the requirements of the European Standard for Child Safety Seat Equipment under Regulation No. 44, 04 series of amendments, for general use in vehicles and it will fit most, but not all, car seats.

A correct fit is likely if the vehicle manufacturer has declared in the vehicle handbook that the vehicle is capable of accepting a “Universal” child restraint for this age group.

This child restraint has been classified as “Universal” under more stringent conditions than those which applied to earlier designs which do not carry this notice.

If in doubt, consult either the child restraint manufacturer or the retailer.

! Only suitable for use in the listed vehicles fitted with 3-point with retractor safety-belts, approved to ECE Regulation No. 16 or other equivalent standards.

The child restraint **IS CERTIFIED** for use in the following classes of vehicles **ONLY**: multi-purpose passenger vehicles, passenger cars, and trucks. Harmony Juvenile Products has also validated compliance through independent laboratory testing.

This restraint is **NOT CERTIFIED** for aircraft use.

This booster seat must **NOT** be used in homes, boats, buses, motorcycles, motor homes, or any other vehicles that have non-forward-facing seats, missing seat belts, or whose seat belts do not meet the requirements of this booster seat.

This booster seat is compatible with vehicle child restraint Lower **A**nchors and **T**ethers for **C**hildren (LATCH).

AIRBAG WARNINGS

! NEVER PLACE THIS BOOSTER SEAT IN A VEHICLE SEATING LOCATION THAT HAS AN ACTIVE FRONTAL AIRBAG. An inflating airbag may cause serious injury or death. Refer to your vehicle owner's manual for information about airbags and child restraint installation.

This booster seat may be used in a rear seating position equipped with side impact airbags providing they are:

- Roof mounted;
- "Curtain" type deployment;
- Will **NOT** interfere with, impact or in any way reposition the booster seat when inflated.

! If a vehicle's front seat location must be used, ALWAYS disable the airbag. Failure to disable the airbag system can result in serious injury or death. Follow the vehicle owner's manual for instructions on disabling the front airbag system.

Please refer to your vehicle owner's manual for airbag type, and for appropriate use with child restraints.

DAMAGE WARNINGS

! It is recommended that the booster seat should be changed when it has been subject to violent stresses in an accident.

! DO NOT USE A BOOSTER SEAT THAT HAS BEEN IN AN ACCIDENT OF ANY KIND. An accident can cause damage to the booster seat that you cannot see.

! DO NOT use this booster seat if it is damaged in any way or has missing parts.

! NEVER use a cut, frayed or damaged vehicle seat belt.

! DO NOT tamper with or modify the booster seat, for any reason. Any unauthorized alterations or additions to the booster seat without the approval of the Type Approval Authority can cause serious injury or death in a sharp turn, sudden stop, or crash.

- ! **DO NOT** use anything to raise the booster seat off the vehicle seat. Untested modifications, such as adding extra padding, could affect the safety of the booster seat and result in serious injury or death in a crash.
- ! **DO NOT, EXCEPT AS DESCRIBED IN THESE INSTRUCTIONS, MODIFY YOUR BOOSTER SEAT, DISASSEMBLE ANY PART OR CHANGE THE WAY THE VEHICLE SEAT BELTS OR LATCH ARE USED.** This includes any accessories or parts by other manufacturers as non-tested accessories can affect the safety of the booster seat.

WEIGHT AND HEIGHT LIMITATIONS

Harmony Juvenile Products recommends that you **ALWAYS** confirm state laws with local authorities. Laws vary from state to state and country to country regarding minimum / maximum booster seat requirements for age, weight and height.

Harmony Juvenile Products advises that your child remains in a high-back booster for as long as possible per the weight and height requirements of the child restraint.

WARNING!

DO NOT USE THIS BOOSTER SEAT IF YOUR CHILD DOES NOT MEET ALL THE REQUIREMENTS BELOW.

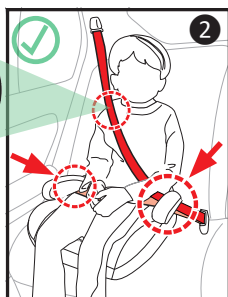
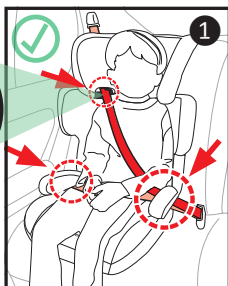
To use this booster seat, your child **MUST MEET ALL** of the following requirements:

- **Weight:** Between 40 - 110 pounds (18.4 - 50 kg).

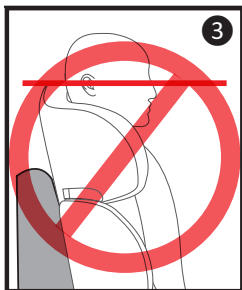
- **Height:** Between 40 - 57 inches (101.6 - 144.8 cm).

- **Age:** at least four (4) years old

- Shoulder belt **MUST** lie across the **MIDDLE** of the child's shoulder and chest **①**, and lap portion **MUST** be positioned low across child's hips **②**.



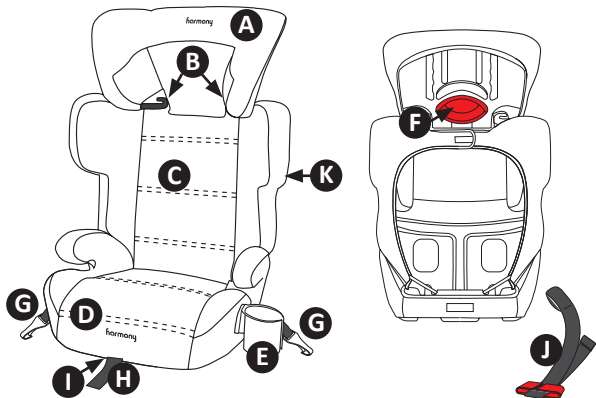
- Child's ears **MUST BE BELOW** the top of the booster seat (with backrest) ③ or the top of the vehicle seat back/vehicle headrest (without backrest) ④. If tops of ears are above the top of the booster seat or vehicle seat back/vehicle headrest, child is too large for the booster seat.

VEHICLE SEATING POSITIONS

WARNING!

FAILURE TO PROPERLY SECURE YOUR CHILD AND THE BOOSTER SEAT IN YOUR VEHICLE INCREASES THE RISK OF SERIOUS INJURY OR DEATH IN THE EVENT OF A SHARP TURN, SUDDEN STOP OR CRASH.

WARNING!

IMPROPER PLACEMENT OF THE BOOSTER SEAT INCREASES THE RISK OF SERIOUS INJURY OR DEATH.

Some seating positions in your vehicle may **NOT** be safe for this booster seat. Some vehicles have **NO** seating positions which are compatible with this booster seat due to seating surface, seat belt type and/or airbag system. Read and follow these instructions, and your vehicle owner's manual carefully.

WARNING!

Children aged 13 and under **MUST** ride in the rear seats, away from front airbags. The only exception is if the airbags are turned off. When using a booster seat in a vehicle with active airbags, refer to the vehicle owner's manual for additional installation instructions and precautions. For rear seat installation, adjust the front seat forward enough to ensure the child's feet do not hit the backrest of the front seat.



WARNING!

Only use this booster seat in forward-facing vehicle seats. Side-facing or rear-facing seats in vans, station wagons or trucks **CANNOT** be used.

THE VEHICLE SEAT MUST FACE FORWARD. DO NOT use the booster seat with the following vehicle seats:

- Seats which face sides of vehicle.
- Seats which face rear of vehicle.
- Rear seats of small extended cab pickup trucks.



- The front of the booster seat **MUST NOT** hang over the edge of the vehicle seat by more than 2 inches (5 cm).

Refer to the vehicle owner's manual for child restraint installation instructions for your specific vehicle.



! DO NOT use this booster seat in a seating position where the vehicle seat belt or seat belt buckle is not easily accessible with the booster seat secured in place.

SAFE VEHICLE SEAT BELT SYSTEMS



WARNING!

SEAT BELTS DIFFER FROM VEHICLE TO VEHICLE AND FROM SEATING LOCATION TO SEATING LOCATION WITHIN THE SAME VEHICLE. NOT ALL VEHICLE SEAT BELTS CAN BE USED WITH THIS BOOSTER SEAT.

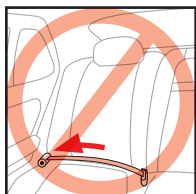
You must determine if your vehicle's seat belts are compatible for use with this booster seat. If you are unsure, consult your vehicle owner's manual or call Harmony Juvenile Products.

! This booster seat is suitable for use in the listed vehicles fitted with 3-point with retractor safety-belts (lap-and-shoulder).

Review your vehicle owner's manual for vehicle seat belt use with booster seats.

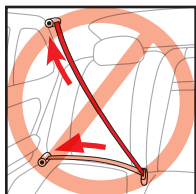
UNSAFE VEHICLE SEAT BELT SYSTEMS

This booster seat can be installed properly using **MOST** vehicle 3-point lap-and-shoulder seat belts. However, some vehicle seat belts are not safe to use as their anchoring points for the lap belt may not allow for a secure installation. **NEVER** use any unsafe vehicle seat belt systems.

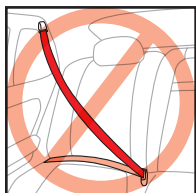


DO NOT USE ANY OF THE FOLLOWING VEHICLE SEAT BELT SYSTEMS WITH THIS BOOSTER SEAT:

! NEVER use a lap-only belt.

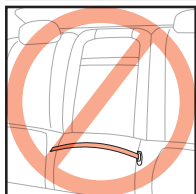


! NEVER use a seat belt that does not lock in the event of a sharp turn, sudden stop, or crash.



! NEVER use a cut, frayed or damaged vehicle seat belt.

! NEVER use motor driven automatic seat belts.



! NEVER use a vehicle seat belt system where the lap and shoulder belts have independent retractors.

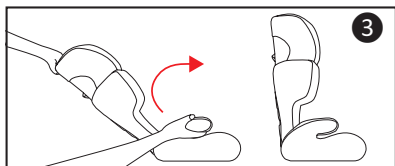
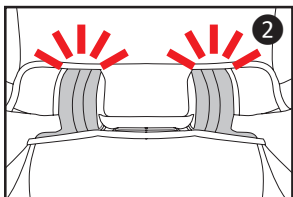
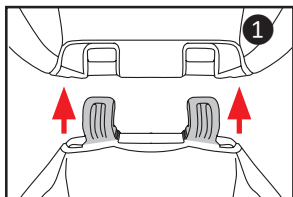
! NEVER use a vehicle seat belt system with top or bottom anchorage points attached to the door in any way.

! NEVER use lap belts whose anchor points are forward of the seat crease.

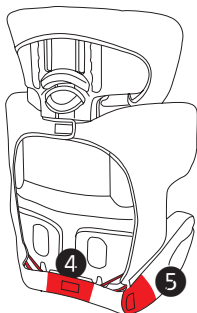
! NEVER use a seat belt system whose anchor points allow the booster seat to slide from side to side when buckled in.

ASSEMBLING/DISASSEMBLING BACKREST

1. Insert 'U-Shape' plastic hooks on bottom of backrest into the corresponding bars on seat base ①. Apply a small amount of force to gently lock the hooks onto base ②.



2. While holding fabric down at rear of seat base, slowly swing the backrest upwards, whereby locking the backrest into place ③. The hook-and-loop portion of the fabric at rear of seat should be **UNDER** the backrest ④.



3. Secure fabric ⑤.
4. To remove backrest, repeat previous steps in reverse order.

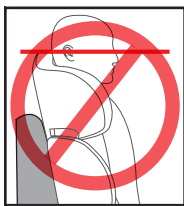
PREPARING BOOSTER SEAT FOR USE

WARNING!

INCORRECT USE OF THE VEHICLE'S 3-POINT LAP-AND-SHOULDER SEAT BELT SYSTEM IS THE MOST COMMON MISTAKE PEOPLE MAKE. IT IS VERY IMPORTANT TO READ, UNDERSTAND AND FOLLOW ALL INSTRUCTIONS AND WARNINGS. DO NOT MISTAKE COMFORT FOR SAFETY. THE VEHICLE'S 3-POINT LAP-AND-SHOULDER SEAT BELT MUST BE SNUGLY ADJUSTED AT ALL TIMES.

! ENSURE the vehicle shoulder belt's position is correct for your child's size. **VERIFY OFTEN.**

! WARNING: DO NOT use this booster seat if the midpoint of your child's head is above the top of the booster seat (with backrest) or the top of the vehicle seat back/vehicle headrest (without backrest).

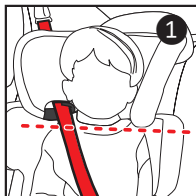
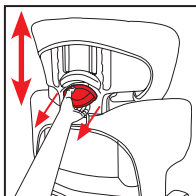


HEADREST HEIGHT ADJUSTMENT

Your booster seat has six (6) height adjustments. Adjust the headrest to properly position the vehicle seat belt as the child grows.

Adjust headrest height so that the shoulder belt is **EVEN** with or **JUST ABOVE** the top of the child's shoulders **1**.

- Pull the Headrest Height Adjuster to raise/lower headrest to desired height.



LATCH (LOWER ANCHORS AND TETHERS FOR CHILDREN)

WARNING!

USE ONLY THE VEHICLE'S 3-POINT LAP-AND-SHOULDER BELT SYSTEM WHEN RESTRAINING THE CHILD IN THIS BOOSTER SEAT.

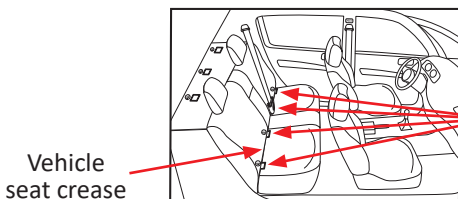
LATCH can be used to secure the booster seat to the vehicle.

LATCH can **ONLY** be used if your vehicle has the LATCH anchors installed and designated LATCH seating positions. Check your vehicle owner's manual to see which seating positions may be equipped with LATCH.

If your vehicle is equipped with LATCH, the vehicle LATCH anchorage points may be visible at the seat crease. If not visible, they may be marked with this symbol.



Check your vehicle owner's manual for your vehicle's exact LATCH locations, anchor identifications and usage requirements for use with a booster seat.

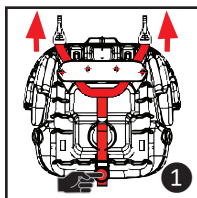
INSTALLING WITH LATCH SYSTEM

WARNING!

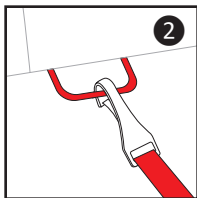
INSTALLING THIS BOOSTER SEAT USING LATCH DOES NOT SECURE THE CHILD. THE VEHICLE'S 3-POINT LAP-AND-SHOULDER BELT MUST BE USED TO SECURE THE CHILD IN THE BOOSTER SEAT.

You must remove the cup holder before using/adjusting the LATCH belt system.

1. Loosen LATCH by pressing upwards on the LATCH release button found directly under the up-front adjuster strap while sliding the LATCH clips out from storage area ①. For ease of installation, extend LATCH to its maximum length. Ensure the LATCH straps are **NOT** twisted and that the LATCH connectors are facing down.

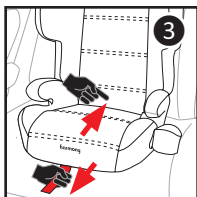


2. Place the booster seat flush against a forward-facing vehicle seat, **CENTERED** between the LATCH anchors.

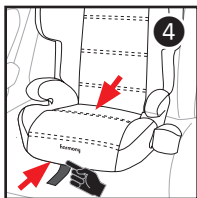


! WARNING: When using LATCH, **DO NOT** place the child restraint off-center of the vehicle anchors.

3. Fasten LATCH hooks to vehicle LATCH anchors ensuring the hooks are facing downwards ②. Pull firmly to be sure that they are attached. Belts must lay flat and not be twisted.

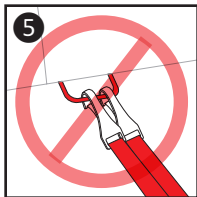


4. Tighten LATCH by pulling on the upfront LATCH adjustment belt while pushing the child restraint towards the vehicle backrest ③.



5. To loosen the LATCH, press upwards on the LATCH release button and pull child restraint forward ④.

! WARNING: **NEVER** put two LATCH connectors on one vehicle LATCH anchor ⑤.



! WARNING: **DO NOT** secure the booster seat to the vehicle's LATCH anchors if the seat belt or seat belt buckle is not easily accessible once the booster seat is latched in place.

SECURING CHILD AND BOOSTER SEAT IN VEHICLE

WARNING!

FAILURE TO PROPERLY SECURE YOUR CHILD IN THE BOOSTER SEAT INCREASES THE RISK OF SERIOUS INJURY OR DEATH IN THE EVENT OF A SHARP TURN, SUDDEN STOP OR CRASH. In a crash, the booster seat provides **NO** protection for your child unless the vehicle 3-point lap-and-shoulder belt is properly secured. Follow these instructions carefully to properly secure your child.

! DO NOT use this booster seat if it can't be properly leveled, stabilized, and installed as per this instruction manual. It is possible that your vehicle has no suitable seating position for this booster seat due to seating surface, seat belt type and/or airbag system. Read and follow these instructions, and your vehicle owner's manual carefully.



! WARNING: Use **ONLY** the vehicle's lap and shoulder belt system when restraining the child in this booster seat **1**. LATCH **WILL NOT** secure your child in the booster seat.



! WARNING: Vehicle belts **MUST** be tight, adjusted to the child's body, and should not be twisted **1**.

! NEVER use a vehicle lap-only belt to secure child in booster seat **2**.

! NEVER USE A LOOSE SHOULDER BELT.

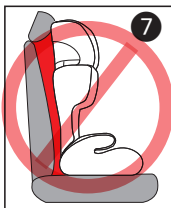
! NEVER position the shoulder belt under the child's arm **3** or place the shoulder belt behind the child's back **4**.

! Lap portion of lap-and-shoulder belt MUST be low and snug across the hips, with the pelvis firmly engaged, just touching the child's thighs. The lap portion **MUST NOT** be lying across the child's stomach as this can cause major injuries to the child in case of a sharp turn, sudden stop or crash.

! DO NOT allow the child to slouch, slide down in the seat, or create slack in the belt system **5**. If child will not keep vehicle belt properly positioned, **DO NOT** use this booster seat.

! DO NOT position vehicle belt over top of the armrests **6**.

! The vehicle seat headrest should not create a gap between vehicle seat and booster seat 7. If so, remove the vehicle headrest.



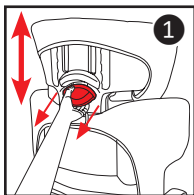
! DO NOT use any load bearing contact points other than those described in the instructions and marked in the child restraint.

IF IN DOUBT ABOUT THESE POINTS OR ANY QUESTIONS RELATED TO INSTALLATION, PLEASE CONTACT HARMONY JUVENILE PRODUCTS.

WARNING!

DUE TO VARYING ANGLES OF VEHICLE SEAT BELT RETRACTORS, EXCESS SLACK IN THE VEHICLE BELT SYSTEM MIGHT NOT BE REMOVED AUTOMATICALLY. Once the lap and shoulder portions of the seat belt are properly positioned and the buckle is attached, FEED ANY REMAINING SLACK OF THE SEAT BELT MANUALLY BACK INTO THE RETRACTOR TO TIGHTEN THE WHOLE SYSTEM.

1. Place the booster seat flush against a forward-facing vehicle seat. The vehicle seat **MUST** be equipped with a 3-point lap-and-shoulder belt. Booster must be level, stable and not rock side-to-side (see "Vehicle seating positions").
2. Place child in the booster seat with child's back flat against the back of the booster seat.
3. Adjust headrest height so that the shoulder belt is **EVEN** with or **JUST ABOVE** the top of the child's shoulders **①**. See section "Headrest height adjustment".
4. Thread shoulder belt portion of the 3-point lap-and-shoulder belt system through the shoulder belt guide **②** and ensure that shoulder belt lies across child's shoulder and chest, and **NOT** across child's face or neck.
5. Thread both sides of the lap belt under **BOTH** armrests. Thread the lower end of the shoulder belt under the



armrest on the buckle side ③. ENSURE that the belt is snug across the child's hips. It is important to ensure that the lap strap is worn low down, so that the pelvis is firmly engaged, just touching their thighs and is **NOT** across their stomach.

6. Buckle the vehicle seat belt into place and ensure it is secure by gently pulling on it.

! BOTH SIDES OF THE LAP BELT MUST PASS UNDER BOTH ARMRESTS, AND THE LOWER END OF THE SHOULDER BELT MUST PASS UNDER THE ARMREST ON THE BUCKLE SIDE.

! The 3-point lap-and-shoulder seat belt should be:

- Tight;
- Adjusted to the child's body;
- **NOT** twisted.

! NEVER USE A VEHICLE LAP-ONLY BELT WHEN USING THIS BOOSTER SEAT.

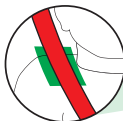
INSTALLATION - BOOSTER WITHOUT BACKREST

See "Assembling/disassembling backrest" for instructions for removing the backrest.

1. Place the booster seat flush against a forward-facing vehicle seat. The vehicle seat **MUST** be equipped with a 3-point lap-and-shoulder belt. Booster must be level, stable and not rock side-to-side (see "Vehicle seating positions").

2. Place child on the booster seat with child's back flat against the vehicle seat.

3. Thread both sides of the lap belt under BOTH armrests. Thread the lower end of the shoulder belt under the armrest on the buckle side ①. ENSURE that the belt is snug across the child's hips. It is important to ensure that the



lap strap is worn low down, so that the pelvis is firmly engaged, just touching their thighs and is **NOT** across their stomach.

4. Buckle the vehicle seat belt into place and ensure it is secure by gently pulling on it.

! BOTH SIDES OF THE LAP BELT MUST PASS UNDER BOTH ARMRESTS, AND THE LOWER END OF THE SHOULDER BELT MUST PASS UNDER THE ARMREST ON THE BUCKLE SIDE.

! The 3-point lap-and-shoulder seat belt should be:

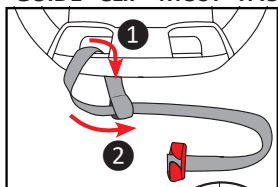

If the belt does not lie properly across the child's shoulder and chest, the **RED** shoulder belt safety guide (“Parts list - J”) **MUST** be used to ensure proper placement (see “Using shoulder belt safety guide”).

INSTALLING/REMOVING SHOULDER BELT SAFETY GUIDE

! OPENING OF RED SAFETY GUIDE CLIP MUST FACE FORWARD.

TO INSTALL:

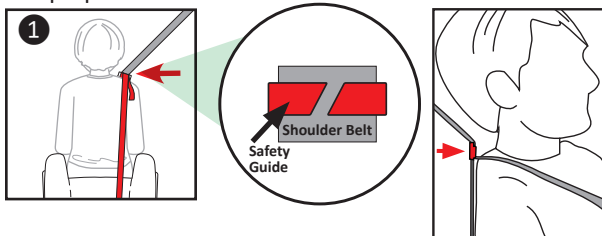
1. Insert loop end of strap around bar on rear of seat **1** on side **OPPOSITE** to the vehicle retractor.
2. Pass the red clip and strap through the loop end **2** and pull strap tight **3**.



It is recommended to store the unused shoulder belt safety guide along with any other parts from the booster seat for future use.

USING SHOULDER BELT SAFETY GUIDE

1. Slide the vehicle's shoulder belt into the **RED** shoulder belt safety guide ensuring it is flat. Position the safety guide just above the child's shoulder **1**. Adjust the belt safety guide by lengthening or shortening strap for a proper fit.



! THE VEHICLE'S SHOULDER BELT MUST LIE ACROSS THE CHILD'S SHOULDER.

ENTANGLEMENT WITH VEHICLE SEAT BELT

! WARNING: To avoid possible entanglement and choking with your vehicle's shoulder belts, Harmony Juvenile Products recommends that the following precautions are taken when installing your booster seat:

1. Pull the shoulder portion of the vehicle seat belt all the way out until the retractor locks.
2. **SLOWLY** let the seat belt retract until it is snug against your child.
3. **ENSURE** that the seat belts do not press on the child's flesh or push the child's body into an unnatural position.
4. Do the same for all unused vehicle seat belts.

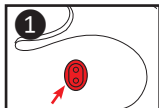
! Teach your child that seat belts are not toys and should NEVER be played with, regardless of whether the car is in motion or not.

! ALWAYS be aware of what your children are doing in the back seat.

USING CUP HOLDER

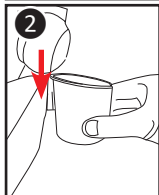
TO INSTALL:

1. Slide cup holder into place over cup holder clip **1** **2** on either side until locked in place.



TO REMOVE:

1. Pull cup holder up and outward.
- The cup holder can be stored under the seat when not in use. To remove from storage, twist cup holder while pulling to release.

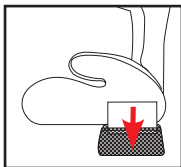


AIRCRAFT INSTALLATION

This restraint is **NOT CERTIFIED** for aircraft use. Aircraft seats are not equipped with 3-point lap-and-shoulder belts which are required for use with this booster seat.

INSTRUCTION MANUAL STORAGE

We recommend that you store your instruction manual inside the mesh pocket located under the fabric on the side of the booster seat. Tuck mesh pocket back under fabric whenever the seat is in use.



REMOVING/INSTALLING FABRIC SEAT COVER

Headrest: Unhook the left and right ELASTIC loops from each shoulder belt guide **1**.

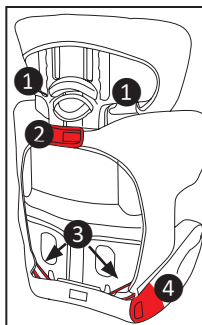
Backrest:

- Unfasten hook-and-loop tab on top of backrest **2**.
- Unhook left and right ELASTIC loops from each of the U-shaped extensions at the bottom of the backrest **3**.

Base: Unfasten hook-and-loop tab from side of seat ④.

TO INSTALL:

To reinstall fabric covers, repeat previous steps in reverse order.



CARE AND MAINTENANCE

CLEANING YOUR SEAT COVER:

- **MACHINE WASH SEPARATELY** using cold water - delicate cycle.
- **DO NOT BLEACH.**
- **DRIP DRY** to prevent cover from shrinking.

! DO NOT wash EPE foam pad insert under seat cover.

CLEANING THE PLASTIC SHELL:

- **SPONGE CLEAN** using warm water and mild soap.
- **TOWEL DRY.**
- **DO NOT** use solvents, abrasive cleaners, or disassemble booster in any way, except as instructed.

CLEANING LATCH STRAPS AND METAL PARTS:

- Spot clean with a damp cloth.
- **DO NOT BLEACH.**
- **DO NOT** immerse the straps in water. Doing so may weaken the straps.
